Dated 8/4/2021 at 10:28AM by email "Dear Respected Members of Peterson's Local School Council, Please read this letter at the next LSC meeting and enter it into the minutes. Given the recent surges of the Delta variant of Covid 19, my husband and I have made the difficult decision to temporarily withdraw our two children from Mary Gage Peterson Elementary School (until they are old enough to be inoculated against Covid 19). For this school year, they will be enrolled in an online academy.

We were hoping the Board of Education for Chicago Public Schools would make a remote option available for grades k-8 (since the vaccine is only approved for people 12 and older).
